In accordance with By-Laws 10.7 PREFIX REGISTRATION

10.7.1 Members of GCCFV may create their own prefix (cattery name) and submit it to GCCFV for approval. Such prefix must not be used until it is approved. An application for a new prefix or a prefix transfer will not be accepted unless: The member has successfully completed the following 2 courses and provides evidence with their prefix application. New members when signing the form are agreeing to an inspection of their cattery 6 months from the date of their prefix approval and a second inspection 12 months from the date of their first inspections.
